REPORT BY THE PRESIDENT

The 2017-2018 season was a significant year of growth and change for OCC with several long time board members rotating off and seven new board members joining.

The board worked diligently to elevate the professionalism of the organization by upgrading our accounting methods, compiling a comprehensive Policy and Procedure Manual, completing a Strategic Plan and rebranding, offering two concerts for our community which were both well received. We also provided a weekly opportunity for our members to develop and flourish as singers. Friendships amongst our members also deepened through various social gatherings and more opportunity to visit at rehearsals.

Additionally, the music selection for the spring concert was more challenging for our members, offering them opportunity for growth in musicality. An ensemble and an intern also provided new opportunities for our members. In June of 2018, the board implemented a summer singing workshop that served those seeking to expand their musical knowledge as well as offer an affordable avenue for musical engagement for community members.

Unquestionably, the strength of the organization lies in the committed leadership and creativity of our board and the strong communication between the Artistic Director, Accompanist and Board Officers. The groundwork has been laid for significant growth next season as we begin the implementation of our Strategic Plan and commemorate our 20th anniversary.

By-Laws Changes

Changes entered September 2017

Article I, Section 1

Change "Oxford Civic Chorus" to "Oxford Civic Chorus, Inc." to match the Corporation's legal name.

Article III, Section 4

Strike "or by proxy" and the final sentence of the paragraph to ensure notification to all members, not just singing members since some corporate members are not singers.

Article IV,

Sections 1

Change minimum number of board members from "eleven (11)" to "nine (9)". Change "shall be comprised of" to "shall comprise." (Grammatical correction)

Change "and the Music Director who shall serve *ex officio* as a non-voting member of the Board."

To "the Music Director, who shall serve ex officio as a non-voting member of the Board; and the Accompanist, who shall at the discretion of the Music Director serve *ex-officio* as a non-voting member of the Board.

Section 2

Strike: "The Music Director shall serve ex officio as a non-voting member of the board."

Revise as follows.

On or before July 1st of each year, the Board of Directors shall select and designate a Music Director who shall have the responsibility, under the general direction of the Board, for all of the musical activities of the Corporation for the coming season. The Music Director shall submit all proposed programs to the Board for its approval as to programmatic and financial feasibility. The Music Director shall select an Accompanist to present for board approval. The Music Director and Accompanist shall be contract employees for the Oxford Civic Chorus.

Article VI

Section 3

Change "in a book provided for the purpose" to "in a book provided for the purpose and by electronic means"

Section 6

Add "The Publicist shall serve ex officio as chair of the Publicity Committee."

Section 8

Strike "preferably in the form of a scrapbook"

Article VIII

Insert the following, with appropriate re-numbering of the subsequent sections.

5. PUBLICITY and MARKETING COMMITTEE

Under the guidance of the Corporation Publicist as chair, the general duties of the Publicity and Marketing Committee shall be: plan and implement marketing strategies for soliciting new board members, singers, and new-member applications for each semester; advertise for each performance; maintain active relationships with all local media outlets and supply them with content about OCC; manage the OCC website and social media; perform other duties as may be assigned by the Board or the Board President.
